Destination Survey 2024 Prize Draw Terms and Conditions

How to enter

Monmouthshire County Council will not accept responsibility for entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.

- 5. Monmouthshire County Council reserves the right to refuse entry, or refuse to award the prize to anyone in breach of these terms and conditions.

Eligibility
